RE: Report on ACCLINATE MOU (#NOWINCLUDED Program) for CARES Act Coronavirus Relief Funds

Dear Director Butler:

Since the execution of our MOU dated October 29, 2020, Acclinate's #NOWINCLUDED Program has worked in collaboration with the Alabama Conference of Black Mayors to increase community engagement within Alabama's underserved and minority communities.

The #NOWINCLUDED Program is (1) developing a coordinated dissemination of information on available COVID-19 testing and treatment, (2) developing and disseminating public health multi-media messaging, and (3) coordinating community healthcare workers to provide education and community engagement related to COVID-19.

Despite having only two weeks to perform for the first reporting period, the #NOWINCLUDED Program produced exceptional results and was seen by over 500,000 people. Below are detailed numbers related to the reach of the various communication channels. Also reported is Acclinate's expenditure of funds to date.
