Dear Director Butler,

In accordance with the *Memorandum of Understanding Between The State of Alabama Department of Finance and Abel Healthcare Enterprises, LLC for the Distribution of Cares Act Coronavirus Relief Funds (MOU)*, please consider this as the report of Abel Healthcare on the expenditure of the funding provided pursuant to the MOU.

Prior to the “return funds” date of December 15, 2020, Abel Healthcare was able to expend the full funding amount under the MOU to provide the licensing software for the VitalEngine collaborative rural healthcare network to each of the entities covered in the MOU—to wit, 53 rural hospitals, 117 rural health clinics, and 231 nursing homes. In addition to these facilities, Abel Healthcare identified one (1) additional rural hospital, ten (10) additional rural health clinics, and three (3) additional nursing homes not contemplated in the MOU. To the end of building out the comprehensive collaborative rural healthcare network contemplated in the MOU, Abel Healthcare provided the licensing software for the VitalEngine network to these facilities as well at no additional cost to the state and at no cost to these facilities.

Complete listings of the facilities to which Abel Healthcare provided the licensing software for the VitalEngine collaborative rural healthcare network prior to December 15, 2020, are attached hereto. (See Attachment A for listing of rural hospitals, Attachment B for listing of nursing homes, and Attachment C for listing of rural health clinics). These listings also include the name and contact information of the person at each facility with whom Abel Healthcare has been in contact regarding the licensing software for the VitalEngine collaborative rural healthcare network.

Moreover, also prior to the “return funds” date of December 15, 2020, Abel Healthcare was able to offer training sessions to each of the listed rural healthcare entities, as required by the MOU. Please refer to Attachment D to this report for a listing of dates and times on which these trainings were delivered, as well as a brief description of the content of the training sessions. Of course, Abel Healthcare remains available until December 30 to continue to work with any of the covered rural healthcare entities for further training on their VitalEngine account as needed on a facility-by-facility basis.

It is our understanding that, as of the submission of this report, Abel Healthcare has complied with all of its requirements under the MOU; provided, however, that Abel Healthcare remains available to answer questions and offer additional training and guidance on the VitalEngine software to covered healthcare facilities until and including December 30, 2020, as mentioned above. If you have any questions regarding the use of the CARES Act funding provided to Abel Healthcare under the MOU, please let us know as soon as possible so that we can clarify and or/rectify any issues prior to the stop-work date of December 30, 2020. However, as mentioned above, we believe that Abel Healthcare has fully complied with its requirements under the MOU.

Director Butler, it has been a pleasure to be able to build out the VitalEngine collaborative rural healthcare network using CARES Act funding over these past several weeks. Thank you, and I hope you have a very Merry Christmas and Happy New Year.
